

TERMS AND CONDITIONS

University College London Hospitals (UCLH) Annual Research Open Day 2019 Free Prize Draw

2. Under the Gambling Act 2005, this Draw is defined as a 'Free Prize Draw' and as such does not require a licence from the Gambling Commission.

13. UCLH reserves the right to re-draw the prize if the winner cannot be contacted within one week of the date specified for the Draw.
14. Please allow 28 days for delivery of the Prize. The Promoter accepts no responsibility for the Prize being lost, damaged or delayed in the post.
15. UCLH accepts no responsibility for any loss, damage, injury or disappointment suffered by any entrant or the winner resulting from the use of the prize. Nothing shall exclude UCLH's liability for death or personal injury resulting from its negligence.
